## Rural Municipality of Grahamdale By-Law No. 1080-2024



BEING A BY-LAW OF THE RURAL MUNICIPALITY OF GRAHAMDALE TO PROVIDE FOR THE REMUNERATION OF MEMBERS OF COUNCIL

WHEREAS Section 124(2) of the Municipal Act, S. M. 1996, c. 58 provides as follows:

## Council may set compensation and expenses:

124(2)A council may by By-Law set the types, rates and conditions of payments to be made to or on behalf of members of the council and council committees, other than the committee of a local urban district;

- (a) as compensation for attending to municipal business;
- (b) for expenses incurred while attending to municipal business; and
- (c) for any other purpose relating to municipal business that the council considers appropriate.

AND WHEREAS it is deemed expedient and in the best interest of the Rural Municipality of Grahamdale to provide for the payment of compensation, expenses and for any other purpose relating to municipal business that the Council considers appropriate:

NOW THEREFORE BE IT AND IT IS ENACTED AS A BY-LAW OF THE RURAL MUNICIPALITY OF GRAHAMDALE AS FOLLOWS:

- 1. THAT an indemnity of \$850.00 per month be paid to the Reeve.
- 2, THAT an indemnity of \$750.00 per month be paid to the Deputy Reeve.
- 3. THAT an indemnity of \$700.00 per month be paid to each Councillor.
- 4. THAT the mileage rate of Sixty cents (60 cents) per kilometer be paid to each member of council for each kilometer, each way, travelled from his/her place of residence in the Municipality, to the place of meeting and return to his/her place of residence, to be allowed only once for each meeting attended of the Council or committees thereof. Whenever practical, car-pooling is encouraged when travelling beyond the limits of the R.M. of Grahamdale when two or more delegates are attending.
- 5. THAT an indemnity of \$19.00 per hour shall be paid to a member of Council for each hour actually and necessarily spent by him/her in the performance of such duties, work or services as he/she is required or authorized to perform, plus mileage for each kilometer actually and necessarily travelled by him/her in the performance of the duties, work or services.
- 6. THAT an indemnity of \$152.00 per day (based on an 8 hour day) be paid to a member of the Council, plus mileage and actual accommodation expenses (if applicable), for each day he/she is actually engaged in travelling to, attendance at, and returning from a meeting/convention of an organization for which he/she had been previously authorized by resolution of the Council to attend.

7.	Meal allowance is at a maximum daily rate of \$65.00 - breakdown is as
	follows:

a)	Breakfast	\$15.00
b)	Lunch	\$20.00
c)	Dinner	\$30.00

- 8. THAT monthly compensation for communication expenses for each member of Council shall be \$150.00.
- THAT all such compensation be paid on a monthly basis on the presentation of an approved expense form and approved by Resolution of Council.
- 10. THAT on the passing of this By-Law, The Rural Municipality of Grahamdale By-Law No. 1070-2023 is rescinded.
